

RULES OF THE COMPETITION
"NotBadJam v5"
(hereinafter referred to as "Rules")

1. Competition

- 1.1. "NotBadJam v5" is a competition that will be held in Łódź, Poland, at Senatorska Street 14/16, and its aim is to popularize roller skating, as well as to promote a healthy lifestyle and physical activity in the context of preventing overweight.

The competition will be held on a prepared track and the distinguished people who perform the most interesting and best tricks will be awarded on the terms and conditions specified in the Regulations (hereinafter referred to as the "Competition").

- 1.2. The competition will take place on **May 9, 2026**.
- 1.3. Participation in the Competition is voluntary. A Participant entering the Competition undertakes to comply with the rules contained in the Regulations, and also confirms that he/she meets and accepts all the conditions described therein.

2. Competition Organizers

- 2.1. The Competition Organizer and the Main Prize Sponsor is the INDIGO NAILS Foundation with its registered office in Łódź at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Commercial Division of the National Court Register under the KRS number: 0000668809, NIP: 7292715719 and REGON: 3668446101.

(hereinafter referred to as the "**Organizer**").

- 2.2. The Competition is not a game of chance, a raffle, a mutual bet, a promotional lottery, a game whose outcome depends on chance, or any other game within the meaning of the Gambling Act of 19 November 2009.

3. Participants

- 3.1. The Competition is open to persons who meet all of the following conditions:

- 3.1.1. are of legal age (with full legal capacity) or have the written consent of their legal guardians to participate in the Competition;
- 3.1.2. are not an employee of the Organizer, or an employee of other entities acting on behalf of the Organizer in connection with conducting the Competition, or a family member of such a person (i.e. ascendant, descendant, sibling, spouse or a person in an adoption relationship with such persons);
- 3.1.3. received an invitation to participate in the Competition from the Organizer or registered to start in the Competition;
- 3.1.4. are aware of the risks associated with participating in the Competition and accept them;
- 3.1.5. their health condition allows them to participate in the Competition;
- 3.1.6. have the equipment necessary to participate in the Competition;
- 3.1.7. meet other requirements specified in the Regulations;

- 3.1.8. grant the Organizer the right to use their image recorded by/in photos and recordings from the Competition;
- 3.1.9. accepted the Rules of Participation in the Competition and submitted to the Organizer an electronic application for participation in the Competition.

(hereinafter referred to as the "**Participant**").

- 3.2. People who do not meet any of the above criteria cannot take part in the Competition. The Participant must meet all the conditions of participation in the Competition both on the day of registration and at the time of starting in the Competition. If it is found that the Participant does not meet the requirements set out in the Regulations, the Organizer may refuse him the right to participate in the Competition or refuse to pay the prize.
- 3.3. Only a person who meets the above conditions may take part in the Competition; it is forbidden to give up one's place to another person.

4. Rules during the Competition and on the premises where it is organized

- 4.1. Participants must strictly adhere to the Rules when taking part in the Competition. Participants are also required to comply with all orders, announcements and guidelines of judges, security personnel present at the Competition venue and the Organizer's staff. Participants must be aware that due to the nature of the Competition, the Organizer is unable to guarantee their full safety.
- 4.2. Participation in the Competition involves a number of potential risks and threats, including to the life or health of the Participants, related primarily to the specific nature of the sports discipline practised during the Competition.
- 4.3. By deciding to take part in the Competition, the Participant declares that he/she is aware of all these risks and threats, accepts them and takes responsibility for them. **Participation in the Competition is voluntary and takes place at the Participant's sole risk!** The Organizer is not responsible for any injuries that Participants may suffer during the Competition.
- 4.4. In order to ensure the safety of Participants, a medical aid point will be set up within the Competition area in case Participants require emergency assistance.
- 4.5. By taking part in the Competition, Participants undertake in particular to:
 - 4.5.1. adapt participation to your health and current well-being;
 - 4.5.2. observe the rules of Fair Play – the Organizer or referees have the right to disqualify a competitor for unsportsmanlike conduct (in particular: disturbing other competitors, destroying property, calling attention to members of the refereeing committee, etc.);
 - 4.5.3. immediately inform the staff on the Competition premises about any noticed irregularities, failures or damages in the equipment or infrastructure of the Competition venue;
 - 4.5.4. immediately inform the staff on the premises of the Competition in the event of any threats to the safety and health of people or property;
 - 4.5.5. take care of your own safety and the safety of others by observing the principles of caution and limited trust in other people using the Competition area;

- 4.5.6. provide themselves with appropriate clothing, footwear, roller skates, personal protective equipment and technical means in accordance with the provisions of law and requirements arising from the manner of use of the Competition area;
 - 4.5.7. observe and comply with warning signs and signals (visual and audible) issued by judges, Competition staff or the Organizer;
 - 4.5.8. After completing your participation in the Competition, collect your equipment and leave the Competition area in proper order.
- 4.6. Persons staying on the premises of the Competition organisation (Participants and all other persons) undertake to maintain order and also respect the following prohibitions - on the premises of the Competition organisation it is prohibited to:
- 4.6.1. possession or consumption of alcohol or other narcotic or psychoactive substances;
 - 4.6.2. possession of weapons or other dangerous objects, explosives, pyrotechnic products, fire hazard materials;
 - 4.6.3. destruction of signs and information boards, advertising media, devices and equipment;
 - 4.6.4. taking any action that may pose a threat to the life, health or safety of persons present at the Competition premises;
 - 4.6.5. using any remote-controlled devices, in particular drones, etc. without the consent of the Organizer.
- 4.7. Access to technical devices located in the Competition area is prohibited for Participants, and the Participant is financially liable for any damage to the technical devices. Technical devices may only be operated by authorized persons.
- 4.8. The Organizer is not responsible for any items left at the Competition premises.
- 4.9. Each Participant is fully responsible for his/her actions or omissions and any damage resulting therefrom, in particular for events caused by sports activities, for the destruction of property located on the premises of the Competition, and undertakes to take over and satisfy all third party claims arising from this.
- 4.10. The Organizer shall not be liable for any damage caused by Participants to themselves, other Participants or the owner of the Competition area, nor for the consequences of accidents resulting from the failure of persons staying on the Competition area or persons using the Competition area infrastructure to comply with the provisions of these Regulations and the orders and instructions of the staff.
- 4.11. The Organizer is not responsible for the effects of Force Majeure. Force Majeure is defined as events beyond the control of the Organizer, which make it impossible or may be considered impossible to fulfill obligations due to the circumstances. Force Majeure includes in particular: weather conditions, failures or disruptions in the operation of devices supplying electricity, heat, light, warfare or actions of state or local government authorities in the field of formulating policies, laws and regulations affecting the fulfillment of obligations.

- 4.12. The Organizer is entitled to refuse a Participant participation in the Competition or entry to the Competition area, without the obligation to notify him or her of this and without the right to any compensation, if:
- 4.12.1. The Participant will be under the influence of alcohol or other intoxicating substances;
 - 4.12.2. there are changes in the course of the Competition due to unforeseen and unavoidable reasons (e.g. lightning, sea conditions posing a threat to the health and life of the Participants and/or the Competition staff, i.e. medical support, judges, technical staff, strong storm conditions, gusty winds with a speed exceeding 20 m/s, water and air pollution, random events and accidents, lack of waves, equipment failure, etc.);
 - 4.12.3. there will be changes to the Competition schedule, shortening or cancellation of the Competition.

5. Course of the Competition

- 5.1. The competition will be conducted according to the following rules:
- 5.1.1. The competition will be held in 5 categories – BLADIES OPEN, BLADIES JUNIOR (up to 16 years of age), MENS OPEN, and MENS JUNIOR (up to 16 years of age), ODB (over 40 years); Additionally, in the JUNIOR categories, KADET BLADIES and KADET MEN (up to 13 years of age) competitors will be recognized.
 - 5.1.2. During the JAM rides, participants will perform tricks that will be assessed by the Committee;
 - 5.1.3. The JAM formula involves rides within a set time frame, i.e. 7 minutes, groups of starting people: 5 to 7 people, depending on the number of people registered.
 - 5.1.4. In each category, the final 7 best Participants will be selected, who will take part in an additional final session of the individual categories.
 - 5.1.5. In the event of a large number of Participants, the final session may be cancelled and the riders' runs and scores from the qualifying sessions will be taken into account in the final assessment and classification.
 - 5.1.6. The event will also feature additional competitions in the OPEN category – meaning anyone can participate, regardless of age – apart from the Old Dirty Bastard competition, which is intended for veterans of the sport:
 - Street - Best Trick BLADIES
 - Street - Best Trick MAN
 - Street – Old Dirty Bastards (ODB) - for Participants over 40 years of age
 - Street - Best Trick BLADIES / JUNIOR / KADET
 - Street - Best Trick MAN / JUNIOR / KADET
 - OPEN - Respect Award
 - 5.1.7. The competition will be held in the following order:
 - 1. Qualifications for competitors registered to take part in the competition, divided into appropriate groups.
 - 2. In case of a smaller number of participants in the Cadet group, they will be included in the start with the Junior group.
 - 3. Qualifications will take place in groups of people divided into 7-person 7-minute sessions. The start time of each group is set by the Commission.
 - 4. During the start in their group, competitors have as many attempts as they can complete within the time set by the Committee.
 - 5. 7 Participants will advance from the qualifiers to the finals
 - 6. At the end there will be the finals, i.e. the start of the competitors from the

qualifications who achieved the highest scores for their runs / evolutions from the qualifications.

7. During the final, competitors have as many attempts as they can complete within the time set by the Committee.
8. Awards ceremony.
- 5.1.8. The event's host will be the event's announcer who will supervise the order of the rides.
- 5.1.9. The Commission Judges will evaluate the run and award points based on criteria such as: run content (number, degree of difficulty, originality and variety of tricks), correctly performed tricks, dynamic, confident execution of tricks, demonstrating the competitor's skill, smooth connection of individual tricks (i.e. continuity of sequences), use of infrastructure (ramps, boxes, rails).
- 5.1.10. If a significant number of competitors apply for the Competition, the Committee has the right to decide to divide the competitors into groups. The groups will then start in the time slots designated by the Committee.
- 5.2. The Competition Participant may participate in the Competition only in designated areas. Evolutions performed outside the designated area will not be assessed in any way by the judging panel.
- 5.3. The Organizer is entitled to exclude a Participant from the Competition and remove results from the Competition, in particular in the following cases:
 - 5.3.1. infringement of any third party rights, including in particular: personal rights and copyrights;
 - 5.3.2. when the results have been obtained in an unfair manner, in particular through fraud;
 - 5.3.3. when the Competitor's behaviour promotes vulgarisms, offensive, political, propaganda, religious content or content that is contrary to the law and violates any rights of third parties, including in particular personal rights and copyrights and containing advertising content relating to entities other than the Organizer or the Ordering Party, and when the Participant does not have the rights to use his or her image to the extent specified in the Regulations.

6. Selection of the Winners

- 6.1. A jury panel appointed by the Organizer (hereinafter referred to as the "**Committee**") will be responsible for supervising the course of the Competition, and in particular for selecting the winners (hereinafter referred to as the "**Winners**").
- 6.2. The jury will be tasked with selecting the winners in the appropriate categories, taking into account the correctness and level of difficulty of the runs.
- 6.3. The committee will be made up of selected individuals who have the appropriate level of knowledge to judge this type of competition. The composition of the committee will be announced in a public forum before the start of the event.

7. Awards

- 7.1. The prizes in the Competition are cash and prizes in kind (hereinafter referred to as "**Prizes**").
- 7.2. Prizes provided in the competition are:
 - 7.2.1. I place in the category BLADIES OPEN: Cash 1200 EUR / PD Travel Line Set
 - 7.2.2. II place in the category BLADIES OPEN: Cash 800 EUR

 - 7.2.5. I place in the category MAN OPEN: Cash 1200 EUR / PD Roller Pro

- 7.2.6. II place in the category MAN OPEN: Cash 800 EUR
- 7.2.7. III place in the category MAN OPEN: Cash 500 EUR
- 7.2.8. IV place in the category MAN OPEN: Playlife Tomo Pro Skates
- 7.2.9. I place in the category BLADIES JUNIOR: Cash 100 EUR, Playlife Tomo Pro Skates
- 7.2.10. II place in the category BLADIES JUNIOR: Voucher SkatePro 125 EUR, Material Prizes
- 7.2.11. III place in the category BLADIES JUNIOR: Voucher SkatePro 100 EUR, Material Prizes
- 7.2.12. IV place in the category BLADIES JUNIOR: Voucher SkatePro 50 EUR, Material Prizes
- 7.2.13. I place in the category MEN JUNIOR: Cash 100 EUR, Playlife Tomo Pro Skates
- 7.2.14. II place in the category MEN JUNIOR: Voucher SkatePro 125 EUR, Material Prizes
- 7.2.15. III place in the category MEN JUNIOR: Voucher SkatePro 100 EUR, Material Prizes
- 7.2.16. IV place in the category MEN JUNIOR: Voucher SkatePro 50 EUR, Material Prizes
- 7.2.17. I place in the category BLADIES KADET: Cash 100 EUR, Material Prizes
- 7.2.18. II place in the category BLADIES KADET: Voucher SkatePro 75 EUR, Material Prizes
- 7.2.19. III place in the category BLADIES KADET: Material Prizes
- 7.2.20. IV place in the category BLADIES KADET: Material Prizes
- 7.2.21. I place in the category MEN KADET: Cash 100 EUR, Material Prizes
- 7.2.22. II place in the category MEN KADET: Voucher SkatePro 75 EUR, Material Prizes
- 7.2.23. III place in the category MEN KADET: Material Prizes
- 7.2.24. IV place in the category MEN KADET: Material Prizes
- 7.2.25. I place ODB: Any Roces skate
- 7.2.26. II place ODB: PD Travel Line Set
- 7.2.27. III place ODB: Material Prizes
- 7.2.28. IV place ODB: Material Prizes
- 7.2.29. BLADIES BEST TRICK STREET: Cash 200 EUR
- 7.2.30. MAN BEST TRICK STREET: Cash 200 EUR
- 7.2.31. ODB BEST TRICK STREET: Cash 200 EUR
- 7.2.32. BLADIES JUNIOR / KADET BEST TRICK STREET: Cash 200 EUR
- 7.2.33. MAN JUNIOR / KADET BEST TRICK STREET: Cash 200 EUR
- 7.2.34. RESPECT AWARD: Cash 100 EUR
- 7.3. Cash prizes will be paid to Winners in Euro (EUR).
- 7.4. The Organizer is responsible for delivering the Prizes.
- 7.5. The Winner of the Competition may not waive part of the Prize; waiver of part of the Prize constitutes a waiver of the entire Prize.
- 7.6. The Organizer may refrain from awarding the first or subsequent Prizes if the Winners are not selected according to the criteria specified in the Regulations.
- 8. Information about winning**
- 8.1. The Winners will be selected immediately after the end of the Competition.
- 8.2. Participants will be informed by the Committee about their results through a collective announcement of the competition results.
- 8.3. Prizes will be awarded after the Competition ends, after the results have been announced.
- 8.4. The Organizer is not responsible for the inability to deliver the prize to the Winner.
- 9. Personal data**

- 9.1. Providing personal data by Participants is voluntary, but necessary to participate in the Competition.
- 9.2. The administrator of the personal data of the Participants is the Organizer. The personal data of the Participants are processed by the Administrator in order to conduct the Competition, based on the consent expressed by the Participant and to fulfill the obligations of the Administrator related to the awarding of Prizes.
- 9.3. The legal basis for the processing of personal data is the Participant's consent - Article 6 paragraph 1 letter a) and Article 6 paragraph 1 letter c) of the General Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).
- 9.4. The Participant may contact the data controller at the correspondence address INDIGO NAILS Foundation with its registered office in Łódź at ul. Senatorska 14/16, 93-192 Łódź, and at the e-mail address: nbc@notbadcom.com

- 9.5. The participant has the right to withdraw consent (by sending a message to the e-mail address: nbc@notbadcom.com, this will result in the inability to further participate in the Competition or receive the Prize.
- 9.6. The Participant's personal data will be processed by the Administrator for the period necessary to organise and resolve the Competition, required by the relevant tax regulations and the limitation period for any claims.
- 9.7. The Participant's personal data may be made available or entrusted by the Administrator:
 - 9.7.1. providers of legal and advisory services supporting the Organizer in pursuing valid claims (in particular law firms);
 - 9.7.2. service providers supplying the Organizer with technical and organisational solutions supporting business processes (in particular IT service providers, courier and postal companies, hosting companies).
- 9.8. In connection with data processing by the Administrator, Participants have the following rights:
 - 9.8.1. access to processed data, rectification of data that is incorrect or completion of incomplete data;
 - 9.8.2. withdrawal of consent to processing, whereby the processing of data will be legal until the consent is withdrawn, and the withdrawal of consent will result in the inability to further participate in the Competition;
 - 9.8.3. requesting the restriction of data processing in cases specified by law;
 - 9.8.4. object to the processing of data in the framework of the legitimate interest of the data controller;
 - 9.8.5. transfer of data to another data controller;
 - 9.8.6. lodging a complaint regarding data processing to the President of the Personal Data Protection Office.
- 9.9. Other important information regarding the principles of personal data processing are specified in detail in the [Administrator's Privacy Policy](#).

10. Complaint procedure

- 10.1. Any complaints regarding the manner of conducting the Competition should be reported by Participants to the Commission during the Competition.
- 10.2. The complaint should include a detailed description, justification for the complaint and a request for specific behaviour from the Organizer.
- 10.3. Complaints will be considered immediately after they are submitted.
- 10.4. The participant submitting a complaint will receive the Commission's decision immediately after considering the complaint.
- 10.5. The complaint procedure is voluntary and does not exclude the Participant's right to independently pursue his or her claims through court proceedings.

11. Final provisions

- 11.1. The Competition Rules are available at the Organizer's office and on the Competition website.
- 11.2. The Organizer reserves the right to change the Regulations, provided that this does not result in a deterioration of the Participant's conditions and the rules of participation in the Competition. In the event of a change in the Regulations, information about the change and the new Regulations will be posted on the Competition website in such a way that each Participant will have access to them.
